QVBCC: Commissioner Morris stated that the Main Hall following an event was left unclean. Commissioner Connelly requests Sarah Hawes do a walk-through and have the facility cleaned if needed before each rental.

Commissioner Kuest said that the Job fair for 2019 Business Expo is asking the Port for a \$500 sponsorship. Upon motion Commissioner Kuest, seconded by Commissioner Connelly sponsorship was approved.

INDUSTRIAL PARK 2: Nothing new to report.

INDUSTRIAL PARK 4 (RACEWAY): Larry Julius announced five bids, one being non-responsive, were received for the Raceway Pre-Engineered Building. Mr. Julius stated the low bid was Black Rock Construction & Development, LLC for Schedule A (Pre-Engineered Building) and Schedule B (Storage Yard Gravel Surfacing).

INDUSTRIAL PARK 7: Commissioner Morris stated the City of Quincy is interested in the entire available acreage.

QUINCY WASTEWATER: Commissioner Kuest announced the City would like the Port to take over the Wastewater. Commissioner Kuest shared the letters of support from the Industrial Users Group and is waiting for letters from the City of Quincy. Commissioners agreed to move forward with discussion of taking over the discharge water only.

EDC: Commissioner Kuest reported Teresa Sullivan will lead the 20/20 Vision.

HOSPITAL: Commissioner Kuest reported the hospital is moving forward with Collins and Woerman. The focus is the primary health care and x-ray lab.

COLOCUM RIDGE GOLF COURSE: Commissioner Connelly reported he will be meeting with PUD on Thursday regarding the fiber concrete hut.
