MINUTES: Upon motion by Commissioner Connelly, seconded by Commissioner Kuest the minutes from May 12, 2021, were approved.

PUBLIC HEARING: Commissioner Morris opened the public hearing at 5:00 p.m. and asked the public for comments on the proposed sale of real property, Lot 1 Houston Short Plat to EdgeConnex Real Estate Acquisitions, LLC. There were no public comments, and the public hearing was closed.

LOT 1 HOUSTON SHORT PLAT: Upon motion by Commissioner Connelly, seconded by Commissioner Kuest the Resolution 2021-02 Authorizing the sale of real property and the Purchase and Sale Agreement were approved and signed.

QVBCC: Catalina Blancas reported the Main Hall has a couple events scheduled for June.

INTERMODAL: Commissioner Morris reported the three pedestals have been installed. Due to the shipping issues at the shipping docks the intermodal has been very busy. They are having to switch power every 2 hours due to the number of trailers in the yard. Commissioner Morris has requested a quote for another two pedestals. AIRPORT (AIRPORT AID APPLICATION): Upon motion by Commissioner Kuest, seconded by Commissioner Connelly Resolution 2021-03 Seeking a Washington State Department of Transportation Aviation Division Grant and Guaranteeing Grant Match Funds was approved.

Upon motion by Commissioner Kuest, seconded by Commissioner Connelly the Airport Aid Application was approved.

COLOCKUM RIDGE GOLF COURSE: Commissioner Connelly reported the RV septic system is needing to be repaired. Commissioner Connelly said Basin Septic snaked the pipes but were unable to locate the problem. Commissioners agreed to investigate further before capping the sewer off for the remaining of the season.
