QVBCC: Marlo spoke about having a training session with Sammie Gillie who will be taking over Marlo's position with the event center. After the Commissioners declared a plumbing emergency the plumbing construction is now complete and the center will be cleaned and ready for this weekend's event. Commissioner Morris thanked Marlo for all her efforts, staying on task and wishes her well.

Connie gives update on projects she has been working on, what's to come and her parking lot repair wish list when funding is available. Dan will be working on a dripline for the plants.
