QBEC: Connie Kuest stated she is still working with Fast Lane Signs regarding the mission statement. Connie also mentioned she is looking into some more furniture and possibly a coffee cart for renters to use in the meeting rooms.

COLOCKUM RIDGE GOLF COURSE: Gabe Porter stated the kitchen is open with a limited menu and the new employees are doing well.
