PUBLC COMMENTS: Larry Schaapman from GPUD attended the meeting to give an update on the new power lines that are being installed in Beverly and Beverly Burke Road.

QBEC: Connie reported that she is working with Pat Tobin from Tobin Electric to update the lighting in the main hall. Her plans are to convert all the existing outdated lights to LED lights and get the chamber on their own lighting system. WM Construction has not reached out to Connie on the estimate for the kitchen and door renovations for the main hall. A report was also given on the comparison of revenue for the event center on years 2022 and 2023.

COLOCKUM RIDGE GOLF COURSE: Commissioner Connelly stated that all the seasonal employees have been laid off for the season.

PORT PROTECTIVE SERVICES: Commissioner Morris stated that the Port of Moses Lake has returned Dan's interlocal agreement proposal with some changes and Chris Ries has approved the changes. The interlocal agreement would require Port Protective Services on an as needed basis for special projects.

INTERMODAL: The commissioners discussed the fiber lines that Intermountain will be installing along the easement with Sabey.

RACEWAY: The raceway sale is progressing and expected to close by the last extension date of November 15, 2023.

INDUSTRIAL PARK 5: Michael Woodkey from Gray & Osbourne stated that he is expecting a new design for approval next week. The new design will include additional support for the bridge as the brackets that were needed for spec on the current bridge are not available and the replacements are heavier. After approval the fabrication is expected to be around 6 weeks then the project will be able to commence and be done in time for the next irrigation year.
