Upon motion by Commissioner Kuest, seconded by Commissioner Connelly it was approved that Partnership for Youth can use the meeting room for 20 dates during the 2024 year.

MINUTES: Upon motion by Commissioner Connelly, Seconded by Commissioner Kuest the minutes from November 8, 2023, were approved as printed.

QBEC: Connie reported that her past and present commissioner wall is almost complete. Dan will be installing the picture rails to place the picture frames with the pictures of past and present commissioners. She has also started decorating for Christmas and needs to be done by December 1^{st,} which is the date of the Christmas parade. The Port will be a stop during the parade festivities where kids will take pictures with Santa and receive cookies. The festival of trees will be Dec. 2nd and the port will donate the tree that is in the breezeway. Dan will be working on finishing up the green lights on the front of the building. Pat Boss asked Connie to confirm the dollar amount she had given him since he will be sending out the request for capital budget request soon. COLOCKUM RIDGE GOLF COURSE: Gabe has reported that business has slowed down at the gold course. The new hire for the mechanic position is doing great and Gabe assured the commissioners that he is the perfect fit for the position. Gabe stated that the feedback he receives most from golfers is the condition of the golf carts. He estimates that the repairs on each golf cart will be between \$400-500 for a new clutch. Gabe is meeting with a sales rep from Yamaha later this week to discuss if it would be necessary to change out the clutch on all the carts or if there are other options to reduce costs on the carts that may not necessarily need a whole new clutch.

PORT PROTECTIVE SERVICES: Dan reported that event security for the year has pretty much come to an end at the Quincy Event Center along with the Port of Mattawa. Dan stated that he has talked to the new Mayor of George which is interested in extending the number of hours Port Protective Services is in George.

INTERMODAL: Gavin has requested to purchase one of the boom lifts that he test drove. He believes that is the one that would work the best for the needs of the golf course.
