Commissioner Curt A. Morris called the meeting to order at 4:00 p.m. Present were Commissioner Pat Connelly, Commissioner Brian Kuest, Darci Kleyn, Dahlia De La Rosa, Connie Kuest, Pat Boss, Lary Schaapman, Rich Wallin, Claudia Garcia, Gabe Porter. On the Phone: Chris Ries.

MINUTES: Upon motion by Commissioner Connelly, Seconded by Commissioner Kuest the minutes from November 13, 2024, were approved as printed.

QBEC: Connie stated that she's reached out to a window cleaning company and has received their quote for deep window cleaning once she's reviewed the quote, she will provide the Commissioners with the cost. Connie is also going to reach out to Rising Sun for a snow removal quote. Connie has been working on putting out the bid for the kitchen remodel. Connie requested to purchase 12 new black chairs and a sofa for the Port office lobby. Upon motion by Commissioner Kuest seconded by Commissioner Connelly the purchase of the chairs and sofa was approved.

COLOCKUM RIDGE GOLF COURSE: Gabe stated that they had a great send off for Brenden on Friday. Gabe also stated a representative from PGA of America has reached out to him, and they are working on the job description for a new club house manager.

INTERMODAL: Commissioner Morris stated he is waiting on Mr. Woodkey's revised gate concept, when finished Commissioner Morris will run it by SIP. Commissioner Connelly is working with the drainpipe issue figuring out if it comes with an easement to present to the irrigation district.

Commissioner Morris will attend a meeting with Nucor and Ben Lee of Landau to address the quality of the water.

PORT PROTECTIVE SERVICES: Commissioner Morris presented the Desert Aire Service Agreement. Motion by Commissioner Kuest seconded by Commissioner Connelly the Desert Aire Service Agreement was signed subject to Port of Mattawa signing the interlocal agreement. Commissioner Morris asked if we'd received our ammunition. Darci stated that we have not but that we have ordered a secure lock storage for it once received.

KER PROPERTY: Commissioner Morris stated that Mr. Woodkey is still working on segregating the property lines Mr. Woodkey had to remeasure.

INDUSTRIAL PARK 5: Nothing new to report.

AIRPORT: Commissioner Connelly stated that Trey with Ardurra is working on the new lighting design with the grant that we've received.

BISHOP: Commissioner Morris stated the due diligence period is about to expire. The Commissioners agreed to extend the due diligence period to December 15, 2024, on the PSA with Augusta Winds. Commissioner Morris stated that Agusta Winds may want the Port to consider a property trade.

HOSPITAL: Commissioner Kuest stated our invitation to tour the facility is still open for us, when time is available.

EDC: Commissioner Morris stated that there is an invitation to Cave B for a Community Connect Happy Hour on December 5th if anyone is interested in attending. Commissioner Morris is also setting up a meeting with Ben Lee and Nucor Commissioner Morris will not be attending the meeting.

Grant County PUD update on power: Rich and Larry provided the Commissioners with insights on energy growth and raised some legislative concerns, regarding ports authority to access other power sources. Rich emphasized the need for clarity on partnerships and compliance with CETA, particularly regarding local tribes and potential legislative changes. The conversation also covered various energy solutions, including franchise agreements and the anticipated capacity from the new Tier 1 application, projecting 208 megawatts while addressing concerns about transmission constraints and the need for legislative changes to support power supply growth.
